2. In this regard it is to inform that DGT is going to conduct examination of Practical / ED (Annual System / DST) for the trainees as below: -


- Supplementary and Left Over Trainees Annual System / DST (2018-19, 2018-20 - 1st year & 2nd year)

5. Further, State Directorate is requested to conduct Practical / ED examination as per schedule attached in Annexure-A. As per prevailing practices Question Papers of top ten (10) trades attached in Annexure B will be prepared by DGT. For rest of the trades, State Directorates will prepare the Question Papers. HT for leftover trainees for practical / ED will be available for downloading by 25th Feb 2022. Those who were already appeared in Practical / ED held in Nov/Dec,2021 does not required to appear again and State Directorate is requested to update their Practical / ED marks on NCVT MIS Portal timely. HT for CBT will be available 10 days in advance.




